Today over 50% of Chardonnay and Sauvignon Blanc planted in California are planted to on of the Wente Clones 1964 Mirassou Vineyards plants 300 acres in Monterey County. Mirassou currently has 1,125 acres of vineyards. 1965 Paul Masson builds a winery in Soledad adjoining its Pinnacles Vineyards.
