## MCVGA PROMOTION OF PRODUCT DETAILS AND WINERY CONTRIBUTION GUIDELINE

**MCVGA PROMOTIONAL GUIDELINES:** The following guidelines will be used for the promotion of products at MCVGA events, in MCVGA marketing materials, or in wine shipments.

*Only products that have been paid for under the dues structure can be promoted by the MCVGA.*

- Monterey County wines, or sub appellation therein, may be promoted at all MCVGA events.
- California wines, or sub appellation therein, that are produced (*fermented & aged*) and/or bottled in Monterey County may be promoted at MCVGA consumer, media and trade events.
- Only Monterey County wines, or sub appellation therein, may be sent in the wine shipment program, educational seminars, outside of Monterey County trade events, and designated appellation promotions.

In order to make sure that we are accurately and effectively promoting you as an MCVGA member, please make sure we have the following.

❑ **COMPANY INFORMATION:** So we can accurately represent you, please make sure we have complete information on your contacts, location, vineyards, tasting rooms, varietals, brands, etc. Remember to let us know if there are any changes in the future.

❑ **LOGO:** Winery members must submit current black and white and color logos for marketing purposes. Grower members are encouraged, but not required, to do the same. This can be emailed to [Kalinda@MontereyWines.org](mailto:Kalinda@MontereyWines.org) no later than January 31, 2018. The logo you submit will be used for marketing materials, events, etc.

❑ **MCVGA WINERY CONTRIBUTION:** Winery membership includes a contribution of 1.5 cases of wine. Wines are used for media, sponsors, and annual event programs. This contribution alleviates the need for wine requests throughout the year. Wine must be received at the MCVGA office by January 31, 2018.
